

ACCREDITATION TO CONECTA CREATIVE LAB – May 25th, 2026
CONECTA FICTION & ENTERTAINMENT, 10th EDITION
ACCREDITATIONS TERMS

1. Introduction and subject-matter

1.1. These contracting and privacy conditions (hereinafter "the Accreditations Terms") regulate the accreditation and participation in the CONECTA CREATIVE LAB, held in the framework of the 10th Edition of the event "CONECTA Magaluf-Mallorca", (hereafter "the Event") international exchange meeting between producers, authors and other participants around the television fiction and entertainment that will be held in Cuenca, Castilla-La Mancha (Spain), in May 25th to 28th 2025 (the "Event"). Full Event information is available on the website www.eventconecta.com (the "Website").

Conecta CREATIVE LAB (hereinafter, "Conecta CREATIVE LAB") is a unique space for reflection on the future of fiction and entertainment production for television, which will be held on May 25th, 2025 at Centro Cultural La Misericordia. During this session, participants will also enjoy a networking lunch. The program and contents of Conecta CREATIVE LAB are published on the Event Conecta website (the "Program"). Likewise, they will be sent by email to those interested in participating.

1.2. The person responsible for the contractual offer is INSIDE CONTENT, S.L. (the "Organizer"), a company incorporated under the Spanish law, with registered office in Clara del Rey, nº 4, 5ª-dcha, 28002 Madrid, Spain, and VAT. B-87731972, registered in the Mercantile Register of Madrid to volume 35592, folio 110, section 8, page number M-639687, and with email: accreditation@insidecontent.tv.

1.3. The participant to Conecta CREATIVE LAB is the person who, meeting the following requirements, duly register for the CREATIVE LAB Workshop (hereinafter referred to as the "Conecta CREATIVE LAB Participant ").

Requirements to be accredited in Conecta CREATIVE LAB:

- (i) The participant in Conecta CREATIVE LAB must be accredited to one of our categories (hybrid, online, day pass, etc.) prior to the activity;
- (ii) be a professional or executive of an audiovisual company;
- (iii) have full capacity to enter into binding contracts.

Depending on capacity, the Event reserves the right to accept or not attendees from the same company.

1.4. The acceptance of these Accreditations Terms is a necessary condition to perform the accreditation in Conecta CREATIVE LAB. In any case, the possession by the Conecta CREATIVE LAB Participant of an accreditation for the Conecta CREATIVE LAB automatically implies the assumption of these Accreditations Terms.

2. Features

The accreditation of the Conecta CREATIVE LAB Participant will give him the right to participate in Conecta CREATIVE LAB, including the enjoyment of the activities, meals and transfers described in the Program.

3. Conditions of accreditation

3.1. The accreditation for Conecta CREATIVE LAB can be purchased until June 12th, 2025 or until filled to capacity. The accreditation can be requested via email, through accreditation@insidecontent.tv, with the sole criterion of the Organizer being the acceptance of applications.

3.2 The accreditation process in Conecta CREATIVE LAB is carried out following the steps below:

- Completion of the Accreditation Form online.
- Completed the Accreditation Form, the Organizer evaluate the fulfillment of the requirements of the professional proposed for participation in Conecta CREATIVE LAB.
- Once confirmed the participation the Conecta CREATIVE LAB Participant shall accept these Accreditations Terms to continue the process.
- Once accepted the Accreditation Terms, the system will redirect to the payment gateway PAYPAL where it will be possible to make the payment by credit card. In default of PAYPAL payment can be made by bank transfer to the account number the Organizer that will be provided by email to the Conecta CREATIVE LAB Participant requesting it so to accreditation@insidecontent.tv.
- Once the payment is accepted, the Conecta CREATIVE LAB Participant will receive an email confirming his/her accreditation in Conecta CREATIVE LAB. In case of payment by bank transfer, the Conecta CREATIVE

LAB Participant must send proof of the transfer made to the email accreditation@insidecontent.tv and, upon receiving the transfer, will receive an email confirming his/her accreditation in Conecta CREATIVE LAB.

4. Prices and payment

4.1. Accreditation prices in the Conecta CREATIVE LAB are published on the Website. Unless expressly stated otherwise, these prices do not include VAT, provided that this tax is applicable.

4.2. The Organizer may unilaterally revise and modify the prices posted on the Website.

In any case, before final payment is made, the Conecta CREATIVE LAB Participant will be informed of the final price of the accreditation, which will be appropriate to the information provided at that time on the Website.

4.3. Payment will be made by credit or debit card. To make the payment, Conecta CREATIVE LAB Participant will be redirected to the PAYPAL payment gateway, where credit or debit card details shall be provided to make the payment.

4.4. Charges will be made on the credit card at the time of the accreditation, which will be confirmed at the time of confirmation of payment. In case the charge has not been possible for any circumstance, the accreditation will not be considered confirmed.

4.5. If the Conecta CREATIVE LAB Participant needs an invoice, he/her must request it by sending an email to the e-mail address indicated in section 1.2 of these Accreditations Terms.

5. Right of withdrawal, policy of changes and cancellation of accreditations and cancellation of the Conecta CREATIVE LAB

5.1. Pursuant to article 103 of Royal Legislative Decree 1/2007, of November 16, approving the Consolidated Text of the General Law for the Defense of Consumers and Users and other complementary laws, it will not be applicable to this contract the right of withdrawal. Not being able to attend Conecta CREATIVE LAB is not a reason to terminate this contract and does not give the Conecta CREATIVE LAB Participant the right to reimbursement of any amount or cost.

5.2. The Conecta CREATIVE LAB Participant may request changes regarding his/her accreditation (e.g. change in the person who will attend Conecta CREATIVE LAB), by means of an e-mail to the email address indicated in section 1.2, no later than May 21st, 2026, included. The Organizer reserves the right to accept or deny such changes. If the requested change is accepted, the Organizer will send an email to the Conecta CREATIVE LAB Participant confirming the made change. No change request received after May 21st, 2026, will be considered.

5.3. The Organizer will only accept cancellation of accreditations when the request for cancellation is received by the Organizer in writing, to the e-mail address indicated in section 1.2 of these Accreditations Terms, before April 25th, 2026. In such case, it will be refunded to the Conecta CREATIVE LAB Participant 50% of the amount paid by the latter for his/her accreditation, by bank transfer, within a maximum period of 30 days from the end of the Event.

Cancellation of accreditations will not be accepted and refunds of payments for accreditations will not be made, for whatever reason, from April 25th, 2026.

5.4. The Organizer reserves the right to refuse entry to or to have expelled, temporarily or permanently, any Conecta CREATIVE LAB Participant whose presence, conduct or behavior threatens the image, peace or safety of Conecta CREATIVE LAB and/or of the other Conecta CREATIVE LAB Participants and/or of the Organizer and/or the integrity of the facilities where it is held. In such case, the Conecta CREATIVE LAB Participant shall be reimbursed the price already paid for the accreditation on a pro rata basis according to the time remaining from expulsion to the end of Conecta CREATIVE LAB.

5.5 In the case of cancellation of Conecta CREATIVE LAB, the Organizer will refund to the Conecta CREATIVE LAB Participant the amount satisfied by the accreditation in the shortest possible time and in any case within a maximum period of 30 days from the communication of the cancellation.

6. Customer Support

6.1. The Assistant to the Workshop may make any inquiries regarding his/her accreditation to the Event by sending an email to the address stated in section 1.2.

7. Protection of personal data

7.1. The data provided by the Conecta CREATIVE LAB Participant through the Accreditation Form (being mandatory, to carry out the accreditation to facilitate those marked with an asterisk) as well as those obtained in connection with other activities carried out in or related to Conecta CREATIVE LAB, will be treated under the responsibility of INSIDE CONTENT, S.L.

7.2. The collection and processing of data is intended to manage the accreditation, attendance and participation of the Conecta CREATIVE LAB Participant in the Conecta CREATIVE LAB, as well as to send to the Conecta CREATIVE LAB Participant information, promotions and publicity and other commercial or non-commercial communications related to the Event and newsletters, to update the Organizer's records, to display and manage contents and communications with the Conecta CREATIVE LAB Participant, to respond to communications made by the Conecta CREATIVE LAB Participant and to comply with any legal requirements and will be processed by INSIDE CONTENT, S.L. to the extent necessary to meet those needs. The Conecta CREATIVE LAB Participant authorizes INSIDE CONTENT, S.L. to keep and process its personal data for the purposes described above for the future editions of Event Conecta.

7.3. The credit or debit card data that the Conecta CREATIVE LAB Participant uses for the payment of his/her credit will be provided directly to PAYPAL; the Organizer does not have access to such information.

7.4. The Conecta CREATIVE LAB Participant guarantees that the data provided is correct, committing to communicate to the Organizer changes on said data. In case the Conecta CREATIVE LAB Participant provides the required data incompletely or inaccurately, the Organizer does not guarantee the accreditation; only the Conecta CREATIVE LAB Participant responds of the consequences derived from the provision of inaccurate data.

7.5. The Organizer guarantees the confidentiality of the personal data provided by the Conecta CREATIVE LAB Participant, according to the provisions on the rules applicable to the Protection of Personal Data and Services of the Information Society and Electronic Commerce, except as set out below.

7.6. The Organizer informs the Conecta CREATIVE LAB Participant that the identification and contact details provided for the accreditation may be communicated to the collaborating entities in the Event and to those suppliers that manage access and/or provide services to the Event related to the attendance and participation of the Conecta CREATIVE LAB Participant in the Event, solely for the purpose of facilitating such management and provision of services.

7.7 The Organizer reserves the right to use recorded images and photographs of Conecta CREATIVE LAB including several or all participants, as well as the conclusions drawn from the reflections, for public communication and marketing purposes, among others.

7.8. The Conecta CREATIVE LAB Participant may contact the Organizer to freely exercise his/her rights of access, rectification, to erasure, to object, to data portability and to restriction of processing with regards to the data incorporated in its files. To do so, the Conecta CREATIVE LAB Participant shall send a written requirement to the Organizer, by registered mail to Calle López de Hoyos, 64, 1ºE, 28002, Madrid, Spain, or to the email address accreditation@insidecontent.tv, specifying the right that he/she wishes to exercise, accompanied by a copy of an official document that identifies him/her. In any case, INSIDE CONTENT may keep a copy of the data duly blocked, if responsibilities for this agreement can be derived.

7.9. The Conecta CREATIVE LAB Participant shall have the right to lodge a complaint with the Spanish Agency for Data Protection (AEPD) in the case the Conecta CREATIVE LAB Participant understands that any of its rights related to data protection have been breached.

7.10 Any press attending Conecta CREATIVE LAB will not be allowed to divulge data and information shared during Conecta CREATIVE LAB, except with the express authorization of those attending Conecta CREATIVE LAB, or of the Organisation. The Organizer reserves the right to limit the participation of the press in Conecta CREATIVE LAB, depending on availability.

8. Liability

8.1. The Organizer declines any liability that could be derived from an incorrect use by the Conecta CREATIVE LAB Participant of the online purchase procedure.

8.2. Any liability for any damages caused by third parties that are not attributable to the Organizer is also disclaimed.

8.3. The Organizer will not be responsible in case of interruptions, delays, errors and, in general, other inconveniences that have their origin in causes that are beyond the control of the Organizer, and/or due to a negligence or willful misconduct of the Conecta CREATIVE LAB Participant and/or has its origins due or Unforeseen circumstances.

9. Severability and amendment of the Accreditation Terms

9.1. Should any of the clauses of these Accreditations Terms prove to be invalid, void or unenforceable for any reason, such condition shall be excluded and shall not affect the validity or applicability of the remaining conditions.

9.2 The Organizer reserves the right to make changes to these Accreditations Terms. The modifications will be applicable to the accreditations purchased after their publication on the Website.

9.3 The Organizer reserves the right to decide on all matters not regulated in these Accreditations Terms and to add to these Accreditations Terms the clauses convenient to regulate such matters, which will be immediately applicable from their publication on the website of Event Conecta. The Organizer will notify such new conditions to the accredited Conecta CREATIVE LAB Participants when it deems it necessary in view of the incidence of the same in their participation in the Event.

10. Applicable law and forum

The relationships established between the Conecta CREATIVE LAB Participant and INSIDE CONTENT will be governed by Spanish Law. The Conecta CREATIVE LAB Participant and the Organizer, expressly waiving any other jurisdiction that may correspond to them, will submit any controversies and/or litigation to the Courts of Madrid, Spain.

1. Introduction and subject-matter

1.1. These contracting and privacy conditions (hereinafter "the Accreditations Terms") regulate the sale of the accreditation for the attendance to the ninth edition of the Event "CONECTA Magaluf-Mallorca", international exchange meeting between the professionals of the television fiction and entertainment industry that will be held on-site, in Magaluf, Calvià, Mallorca, Balearic Islands (Spain) on May 25-28, 2026 with some activities online in its website, (the "Event") All the Event information is available on the website www.eventconecta.com (the "Website").

1.2. The person responsible for the contractual offer is INSIDE CONTENT, S.L. (The "Organizer"), a company incorporated under the Spanish law, with registered office in Clara del Rey, nº 4, 5º-dcha, 28002 Madrid, Spain, and VAT. B-87731972, registered in the Mercantile Register of Madrid to volume 35592, folio 110, section 8, page number M-639687, and with email: accreditation@insidecontent.tv.

1.3. The assistant is the person who duly register for the Event (hereinafter referred to as the "User"). The User shall be over eighteen (18) years old and have full capacity to enter into binding contracts.

1.4. The acceptance of these Accreditations Terms is a necessary condition to perform the accreditation in the Event. In any case, the possession by the User of an accreditation for the Event automatically implies the assumption of these Accreditations Terms.

2. Features

2.1. Given the main objective of the Event, to promote the exchange and internationalization among professionals of the audiovisual sector for the creation, financing, production, broadcasting and distribution of fiction and entertainment television content. In order to reach this goal, executives of production companies, television networks and platforms, distributors, investors, creative talent, production services companies, talent agencies, lawyers and tax advisors, markets and festivals, press, associations and institutions will have priority in acquiring accreditation for the Event. In view of the number of accredited professionals among these professionals and the total capacity of the Event, the Organizer may accept the accreditation of other professionals from the audiovisual industry, at the discretion of the Organizer.

2.2. The accreditation only gives the User access to the general activities programmed in the Event (including coffee breaks) but does not allow him/her to participate in those other complementary activities for which a specific accreditation is required.

3. Conditions of accreditation

3.1. The accreditation for the event will be open until June 16, 2025, included, or until capacity is reached. The registration for the accreditations must be done through the Website until the closing date, with the exceptional possibility of applying for them via email, through accreditation@insidecontent.tv, when this period has ended.

3.2 The accreditation process in the Event via the Website is carried out following the steps below:

- Completion of the Accreditation Form.
- Completed the Accreditation Form, User shall accept these Accreditations Terms in order to continue the process.
- Accepted the Accreditations Terms the system will redirect to the payment gateway PAYPAL where it will be possible to make the payment by credit card. In default of PAYPAL payment can be made by bank transfer to the account number the Organizer that will be provided by email to the User requesting it so to accreditation@insidecontent.tv
- Once the payment is accepted, the User will receive an email confirming its accreditation in the Event, the invoice and the accreditation ticket. In the case of payment by bank transfer, the User must send proof of the transfer made to the email accreditation@insidecontent.tv and once the transfer is received, he will receive an email confirming his accreditation to the Event, the invoice and the accreditation ticket.

Weeks before the event, the User will receive information on how to proceed to obtain the accreditation (if he/she will receive it by email and will have to bring it printed or will need to pick it up upon arrival at the event).

3.3. At the User's written request, the Organizer will send to the User, to the email address provided by the User on the Accreditation Form, the electronic document proving the execution of these Accreditations Terms.

3.4. Professional press (journalists/photographers) wishing to cover the event shall register online until May 25, 2026, or until filling the capacity. The registration for the accreditations must be done through the Website until the closing date, with the exceptional possibility of applying for them via email, through accreditation@insidecontent.tv, when this period has ended. The accreditation of professionals of the press is reserved for professionals of press specialized in the Audiovisual industry, which must be proven to the Organizer by means of a document certifying that they work or collaborate in a media company and their specialization in the audiovisual industry (i.e. a copy of their current press card, a letter signed by the director with the stamp and data of the company or media, in the case of professionals who perform their activity as freelance specialized in the audiovisual industry, providing graphic proof of a journalistic work signed by the interested party (text/images) of recent publication, or any other at the Organizer's criteria). Accredited Professional Press will not have to pay the price of the Accreditation. The Organizer reserves the right to reject applications for accreditation of those applicants who do not provide sufficient evidence of their status as media professionals of the Audiovisual Industry or when the number of accredited in this condition exceeds the reasonably admissible taking into account the number of professionals of the audiovisual industry accredited. Once the application has been received, the granting of the Accreditation will be confirmed by mail, which the accredited professional can collect at the accreditation desk of CONECTA Magaluf-Mallorca, for which the professional must provide the confirmation email of his accreditation and official document that allow its personal identification (press card, ID, passport, etc.).

Press accreditation must be requested prior to the Event. During the Event, no accreditation will be processed and only the demands of general media of daily information (press, radio and TV) involving the displacement of technical means (mobile units, graphic equipment, etc.) will be processed exclusively.

The Press accreditation will give access to the accredited to all the activities of the Event except for networking scheduled activities (one-to-one meetings, speed-datings, etc.).

3.5 The Badge is strictly personal and non-transferable. Whoever accesses the Event with a Badge that does not belong to him/her will be expelled from the Event and from the facilities where it is held and said Badge will be withdrawn and canceled.

3.6. The User must display the Badge whenever it is required to do so, both in the hall of the Melia Calvia Beach Hotel, and in any facility where any Event activity is held.

3.7. The loss or theft of your Badge must be immediately reported by the affected User at the accreditation desk, in which case it will be replaced by another previous verification by the Organizer of the User's identity (through presentation of ID, passport, etc.) and payment of the accreditation.

4. Prices and payment

4.3. Payment will be made by credit or debit card or exceptionally by bank transfer as mentioned in point 3.2. To make the payment, the User will be redirected to the PAYPAL payment gateway, where he/she will have to provide his/her credit or debit card details to make the payment.

4.4. Charges will be made on the credit card at the time of the accreditation, which will be confirmed at the time of confirmation of payment. In case the charge has not been possible for any circumstance, the accreditation will not be considered confirmed.

4.5. To access the Event, and, as the case may be, to the complementary activities, the User must present his/her Badge.

4.6. If the User requires an invoice, he/she may download it from his/her accredited profile. No change request received after April 25, 2026, will be considered.

5.3. The Organizer will only accept cancellation of accreditations for the Event when the request for cancellation is received by the Organizer in writing, to the e-mail address indicated in section 1.2 of these Accreditations Terms, before April 25, 2026. In such case it will be refunded to the User 50% of the amount paid by the latter for his/her accreditation, by bank transfer, within a maximum period of 30 days from the end of the Event.

Cancellation of accreditations for the Event will not be accepted and refunds of payments for accreditations will not be made, for whatever reason, from April 25, 2026.

5.4. Changes from Hybrid Accreditation to Online Accreditation or vice versa: The User may request changes regarding his/her accreditation for the Event (e.g., Changes from Hybrid Accreditation to Online Accreditation "downgrade" or vice versa "upgrade"), by means of an e-mail to the email address indicated in section 1.2, no later than April 25, 2026, included. The Organizer reserves the right to accept or deny such changes. In the event that the requested change is accepted, the Organizer will send an email to the User confirming the change made. No change request received after April 25, 2026, will be considered.

5.5. This list of participants will be accessible through the Event's website in a restricted way only to the accredited users in the Event and can be accessed from anywhere in the world.

Only the professional data of the Users who purchase their accreditation for the Event until April 25, 2026, will be included in this list of participants until the access to the online platform is closed.

In the event that the User does not wish his/her data to be included in the list of participants or that only some of the data provided through the Accreditation Form are included, he/she must communicate this in writing by e-mail to accreditation@insidecontent.tv before April 25, 2026. The request for non-inclusion of your data in the list of participants may be requested at any time through the same e-mail address.

7.2. The data provided by the Users through the Accreditation Form (being obligatory, to carry out the accreditation, to facilitate those marked with an asterisk) as well as those obtained in connection with other activities carried out in or related to the Event, will be treated under the responsibility of INSIDE CONTENT, S.L.

7.3. The purpose of the collection and processing of data is to manage the accreditations, the attendance and participation of the User in the Event, their inclusion in the list of participants, as well as to send the User information, promotions and advertising and other types of commercial communications or not related to the Event and newsletters of the Event and INSIDE CONTENT, S.L. and collaborators and sponsors of the Event belonging to the audiovisual industry (including the specialized press), update the records of the Organizer, display and manage content and communications with the User, respond to communications made by the User

7.6. Spain, or to the email address accreditation@insidecontent.tv, specifying the right that he/she wishes to exercise, accompanied by a copy of an official document that identifies him/her. The provisions of this paragraph do not apply to the provisions in relation to the Industry Guide, for which it will be in accordance with the previous section 7.1. In any case, INSIDE CONTENT may keep a copy with the data duly blocked, as long as responsibilities for this agreement can be derived.

1.- INTRODUCTION AND PURPOSE

1.1. 1.2 The person responsible for the contractual offer is INSIDE CONTENT, S.L. B- 87731972, registered in the Mercantile Registry of Madrid in volume 35592, folio 110, section 8, page number M-639687 and with e-mail: accreditation@insidecontent.tv

1.3. The person attending the Event in accordance with these Terms and Conditions is the person who, meeting the following requirements, duly registers for the Event (here in after referred to as the "Academic User").

Requirements to be accredited to the Event as an Academic User:

- (i) Be over eighteen (18) years of age.
